MINERS TALK

BENCHES: These are terrace placers. Sections of old streambed that are located high above the present stream of water. These benches may contain large quantities of gold that never washed into the stream.

CALICHE: Most often found in dry placers, this is a light colored material usually containing rocks or gravel cemented together with calcium carbonate. Gold can be found on top of this material.

Troy Weight Conversion Table

1 grain = .0648 grams

24 grains = 1 pennyweight (DWT)

20 DWT = 1 troy ounce

12 troy ounces = 1 troy pound
