**CARRISSA RECLAMATION BEGINS**

The State of Wyoming has taken possession of the Carrissa Mine in Fremont County. Work contracts have been let and construction begun to mitigate environmental concerns at the historic mine. A side shaft, which lies close to the South Pass road, has had its entrance permanently sealed to stop erosion which threatened the road. The mine buildings on the site are being repaired and visitor walks are being installed. Upon completion of the work in 2006 the site will be turned over to the Wyoming Department of State Parks and Cultural Resources. **BLM INCREASES CLAIM FEES**

Washington 1Sep2005,

Today the Bureau of Land Management published in the Federal Register new regulations to increase the costs of mining claims. Effective 1 September 2005 mining claim holders must pay a \$30 location fee and a \$125 maintenance fee for all mining claims and sites recorded on or after June 30, 2005. In addition, the annual maintenance fee due on or before September 1, 2005, is \$125 per mining claim or site. The new fees are an increase of \$5 for the location fee and \$25 for the maintenance fee. If a claimant has pre-paid their location and maintenance fees prior to 1 September 2005 then that claimant has 30 days to pay the difference between the old fees and the new fees.

**BLM ANNOUNCES CLOSURE**

### Vehicle Use

The BLM has decided to close lands in Fremont County, Wyoming, to all types of motor vehicle use. This closure affects public lands located within Fremont County on the National Historic Trails in the area known as Rocky Ridge. The closure area extends for approximately 2 miles from near the Lower Monument over Rocky Ridge to the western edge of the BLM-administered public land in Section 28, T29N, R97W.

This closure will be effective June 20, 2005, in accordance with the Environmental Assessment and Decision Record (March 28, 2005).

### WASHINGTON RELEASES STUDY

The Washington State Department of Ecology has released a report titled Effects of Small-Scale Gold Dredging on Arsenic, Copper, Lead, and Zinc Concentrations in the Similkameen River. The study was completed in March 2005. The conclusions of the report are of interest to us; "Results of this study show that the concentrations of arsenic, copper, lead, and zinc discharged from small-scale gold dredges operating in the Similkameen River are not a significant toxicity concern for aquatic life. Although this activity will exacerbate the exceedances of the arsenic human health criteria that already occur, it would take very large numbers of dredges to effect a 10% change in the river's arsenic levels, even at low-flow conditions."

On Sep 20 the following notice was published in the Federal Register; Shoshone National Forest, Wyoming, Revised Land and Resource Management Plan Forest Service, USDA. [[Page 55103]]

The Forest Service will revise the Land and Resource Management Plan (hereafter referred to as the Forest Plan) for the Shoshone National Forest, WY. This notice describes documents available for review and how to obtain them; summarizes the need to change the Forest Plan; provides information concerning public participation; and includes the names and addresses of agency officials who can provide additional information. To be most beneficial to the planning process your comments on need for change should be submitted by October 21, 2005. The revision process for the Shoshone National Forest officially begins in September 2005 with the

publication of this notice of initiation in the Federal Register. A draft revised forest plan will be published in April 2007. The final revised forest plan will be issued for pre-decisional review in April 2008. Final plan approval is planned for September 2008.
