Notice of Intent NOT Required

Below is the exact wording for the LAW that the FS operates under. If you are not using motorized equipment the FS CANNOT require you to file a Notice of Intent.

§ 228.4 36 CFR Ch. II (7–1–09 Edition)

§ 228.4 Plan of operations—notice of intent—requirements.

(a) Except as provided in paragraph (a)(1) of this section, a notice of intent to operate is required from any person proposing to conduct operations which might cause significant disturbance of surface resources. Such notice of intent to operate shall be submitted to the District Ranger having jurisdiction over the area in which the operations will be conducted. Each notice of intent to operate shall provide information sufficient to identify the area involved, the nature of the proposed operations, the route of access to the area of operations, and the method of transport.

(1) A notice of intent to operate is not required for:

- (i) Operations which will be limited to the use of vehicles on existing public roads or roads used and maintained for National Forest System purposes;
- (ii) Prospecting and sampling which will not cause significant surface resource disturbance and will not involve removal of more than a reasonable amount of mineral deposit for analysis and study which generally might include searching for and occasionally removing small mineral samples or specimens, gold panning, metal detecting, non-motorized hand sluicing, using mining claim;
- (iii) Marking and monumenting a disturbance;
- (iv) Underground operations which will not cause significant surface resource battery operated dry washers, and collecting of mineral specimens using hand tools;
- (v) Operations, which in their totality, will not cause surface resource disturbance which is substantially different than that caused by other users of the National Forest System who are not required to obtain a Forest Service special use authorization, contract, or other written authorization;
- (vi) Operations which will not involve the use of mechanized earthmoving equipment, such as bulldozers or backhoes, or the cutting of trees, unless those operations otherwise might cause a significant disturbance of surface resources;
or
- (vii) Operations for which a proposed plan of operations is submitted for approval;

California Miners Get Golden Reception in Senate Hearing

SACRAMENTO: The Senate Committee on Appropriations threw its full support today behind refund legislation authored by Senator Sam Aanestad (R-Grass Valley). The measure -- SB 889 -- will allow Suction Dredge Miners to request a refund of suction dredge mining permits that were purchased from the California Department of Fish and Game (DFG) in 2009. The vote by the Senate Appropriations Committee moves SB 889 to the Senate Floor. Senator Aanestad introduced refund legislation last December -- after the State Legislature approved emergency action last summer to ban the practice of suction dredge mining in California. Senator Aanestad believes that his legislation is a matter of fairness.

"Thousands of miners followed the letter of the law by purchasing permits in 2009 that would allow them to practice suction dredge mining -- a practice that was later banned during the same year by the State Legislature," said Senator Aanestad. "They paid for a full year of mining activities and they didn't get it. I'm pleased that my colleagues on the other side of the aisle recognize and understand this -- and I'm hopeful for similar success as the bill moves toward a Senate Floor vote."

Nearly 4,000 suction dredge mining permits were purchased last year according to the DFG -- and more than 3,000 of the permits were purchased by California residents alone. The cost of a permit for California residents is \$47.00, and for out of state miners the permit fee is \$185.25. In 2009, the Department collected about \$250,000 from miners who were subsequently denied the right to mine.

The DFG estimates that the passage of SB 889 will cost \$270,000, which will cover the entire cost of permit refunds and administrative costs.

"Some miners have already successfully sued the DFG in small claims court for a full refund of suction dredge mining fees."

Directions to July Outing

1. Travel West on I-80 from Cheyenne to Laramie.
2. Take Exit 311. Turn Left at the bottom of the exit. Go straight and follow Hwy 230 towards Woods Landing.
3. Stay on Hwy 230 from Exit 311 for approximately 35 miles to the sign for Fox Park.
First timers: After Woods Landing Hwy 230 passes through a canyon and the road has some steep grades and sharp curves.
BE CAREFUL!
4. Turn right off of Hwy 230 towards Fox Park on USFS Road 512 (Platte River Access Rd). At Fox Park you must turn left and stay on USFS Road 512.
5. Total dirt road distance from Hwy 230 is approximately 8.3 miles. Look for the campers in the open meadow on the left.
